



Visiting Student Application

Students currently enrolled at another law school have the opportunity to apply as a visiting student at CharlotteLaw. Visiting students are eligible to matriculate for up to one academic year only. Students must have permission from their home law school and must submit all required application materials for consideration by the CharlotteLaw Admissions Committee. Visiting students will receive their degree from the home law school and are not eligible to receive their degree from the Charlotte School of Law.

The Admission Committee will send decisions regarding visiting student status beginning June 1, for the Fall start and November 1 for the Spring start. Seats are limited. Visiting students are responsible for submitting updated grades for all course work completed after a decision on visiting status has been made. Additionally, visiting students are responsible for reporting any legal or academic disciplinary matters that arise prior to the start of the semester.
